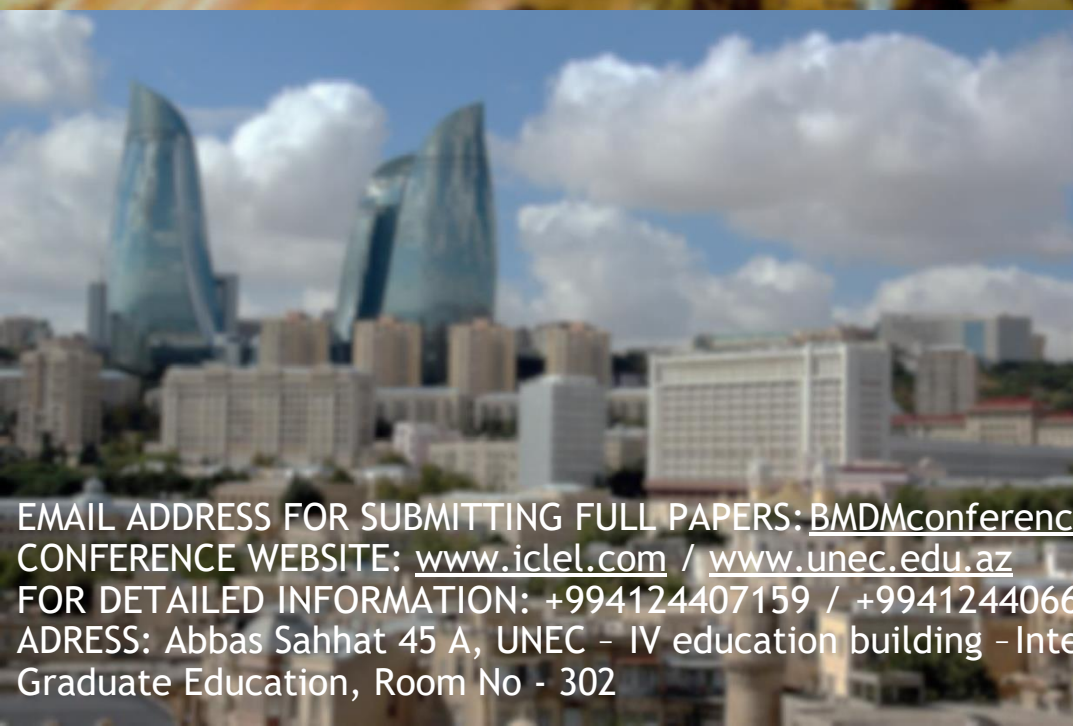

PAPER SUBMISSION GUIDELINES

Page margins: left: 3cm, right: 2cm, top and bottom: 2.5cm

Title: bold, center, times new roman 14 font size, only first characters of each words in uppercase

Authors: author first name, surname, university and e-mail; bold, center, italic, times new roman 12 font size.

Abstract: Minimum 200 - maximum 250 words; times new roman 10 font size, 1.15 spacing between lines, justified.

Keywords: Minimum 3 - maximum 5 words

Full Paper Text

1- Times New Roman 12 font size

2- Justified

3- Spacing - 1.15

4- 0 (zero) space after and before paragraphs

5- 1 (one) space before paragraphs

Headings:

6- Main headings: bold, align left, times new roman 12 font size, all capital letters.

7- Sub-headings: bold, align left, times new roman 12 font size, only first character of sub-heading in uppercase

8- Sub-headings to be used:

- Introduction
- Method
- Analysis
- Conclusions and Recommendations
- References

Tables and figures:

Texts and notes in tables/figures should be times new roman 10 font size, single spacing between lines.



Page numbering:

Page numbers should be placed in the right corner of the page.

Citations:

All Citations and References should follow APA format (e.g., author’s surname after the sentence in parentheses with the date and page number). Sample: (Drucker, 2007: s. 98-99).

References:

0 (zero) space after and before paragraphs, times new roman 10 font size.

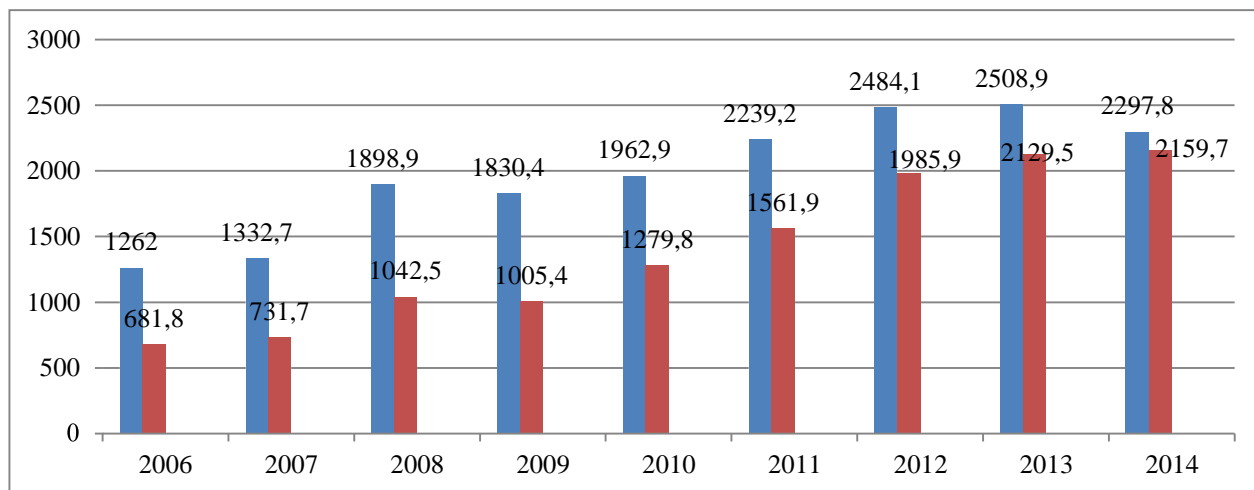
